In consideration of the acceptance of the enrollment of the above child by Tucson Waldorf School, the undersigned agree(s) to pay the above-listed Extended Care tuition for the academic year in accordance with provisions of this agreement.

Extended Care charges are payable in monthly payments. The first monthly Extended Care payment is due September 1, 2011.

Extended care fees shall be due and payable on the first day of the month and are considered late after the 10th of the month. If tuition is not paid by the 10th of the month, late fees and finance charges will be applied at the same rate as late tuition. The Tucson Waldorf School may also suspend the enrollment of a child for whom tuition is not paid according to the terms of this contract, and/or declare the balance of the full Extended Care tuition herein provided immediately due and payable. The procedure for addressing late or delinquent accounts may be reviewed in the school office by any parent, guardian, or other individual responsible for payment of the child's tuition and fees.

The enrollment of the child shall be subject to all rules and regulations established by the Faculty and Board of Trustees of Tucson Waldorf School and are reflected in the Student Contract.

If the undersigned find that they need to change the days and or hours of the Extended Care, they must sign a new contract. All Extended Care services are charged by the month. Every change to a contract will incur a \$25.00 charge to cover associated administrative costs. Extended Care fees may be prepaid, but will not be refunded for any reason.

Late fees will be applied for applied if your child is not picked up at the appointed time.

The enrollment of the child shall be subject to all rules and regulations established by the Faculty and Board of Trustees of Tucson Waldorf School and are reflected in the Parent Handbook and Student Contract.

All parents, guardians, or other persons responsible for payments should read the provisions of this contract, complete the required information, sign, and return the contract to Tucson Waldorf School accompanied by the non-refundable registration fee. *A student is accepted for enrollment or re-enrollment only when the contract has been delivered to Tucson Waldorf School, signed and dated, and accompanied by **all appropriate fees and forms.***
